With reference to your application dated 23/06/2015, I am directed to convey sanction for Regular Affiliation to the above said school for Senior School Certificate Examination (Classes XI to XII) w.e.f. **01/04/2016** onwards in the following subjects:-

Core Language : ENGLISH.

Elective Subjects: PUNJABI, MATHEMATICS, PHYSICS, CHEMISTRY, BIOLOGY, PHYSICAL EDUCATION, COMPUTER SCIENCE, INFORMATICS PRACTICES, ECONOMICS ACCOUNTANCY, BUSINESS STUDIES, POLITICAL SCIENCE, HISTROY, GEOGRAPHY, HOME SCIENCE & SOCIOLOGY.

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of affiliation for secondary classes:

1. The school will provide additional suitable facilities for classes XI and XII, as per requirements.
2. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
3. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
4. It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
5. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.

6. It will continue to pay an Annual Fee of **Rs. 3000/- p.a.** The schools run by KV/ KVS/ NVS/ Army/Navy/Air Force/Military/ Govt./Govt. Aided/Sainik/Railway/Atomic Energy etc. are granted regular affiliation and these schools have been advised to remit prescribed annual fee by D.D. in favour of **Secretary, CBSE, payable at Delhi.** This may be complied in future.
7. **Annual fee has been received upto 31/03/2018.**
8. Special conditions to be complied within three months:-
 - i) **The school is required to improve the library services and more periodicals, dailies and books to be added in the library.**
 - ii) **The school is required to purchase more computers for Computer Lab.**
 - iii) **Labs should be equipped with more apparatus and equipments.**
